## TERMS AND CONDITIONS

**Reservations:** A \$1,000 per person deposit, along with a completed and signed reservation form, will reserve a place for each participant on this program. The balance of the trip is due on or before May 15, 2018.

**Cancellations and Refund Policy:** Notification of cancellation must be received in writing. At the time we receive your written cancellation, the following penalties will apply:

- ◆ Cancellations made 48 hours after the reservation is booked (if cancelled before May 15, 2018) are subject to 50% of deposit (\$500) to cover administrative costs and handling regardless of the reason for cancellation.
- ◆ Cancellations made 90 to 64 days prior to departure are charged 25% of the tour cost (per person).
- ◆ Cancellations made 64 to 30 days prior to departure are charged 70% of the tour cost (per person).
- ◆ Cancellations made 30 to 1 day prior to departure are charged 100% of the tour cost (per person).

Aurora Theatre Company and Dramarama Theater Tours (DTT) reserve the right to cancel the tour and refund all payment if the tour does not reach minimum capacity. No refunds will be made for missed performances, meals, alternate transportation, sightseeing tours, absences or any other unused portion of the tour. Aurora Theatre Company and DTT do not accept liability for cancellation penalties related to domestic or international airline tickets purchased in conjunction with the tour.

**Trip Cancellation and Interruption Insurance:** We strongly advise that all travelers purchase trip cancellation and interruption insurance as coverage against an unforeseen emergency that may force you to cancel or leave the trip while it is in progress. If a trip must be delayed, or the itinerary changed due to bad weather, road conditions, transportation delays, airline schedules, government intervention, sickers, or other contingency for which Aurora Theatre Company and DTT or its agents cannot make provision, the cost of delay or changes is not included.

**Limitations of Liability:** Aurora Theatre Company and DTT, its Owners, Agents and Employees act only as the agent for any transportation carrier, hotel, ground operator, or other suppliers or services connected with this program ("other providers") and the other providers are solely responsible and liable for providing their respective services. Aurora Theatre Company and DTT shall not be held liable for (A) any damage to, or loss of, property or injury to, or death of persons occasioned directly or indirectly by an act or omission of any other provider, including but not limited to any defect in any aircraft, or vehicle operated or provided by such other provider, and (B) any loss or damage due to delay, cancellation or disruption in any manner caused by the laws, regulations, acts or failures to act, demands, orders, or interpositions of any government or any subdivision or agent thereof, or by acts of God, strikes, fire, flood, war, rebellion, terrorism, insurrection, sickness, quarantine, epidemics, theft, or any other cause beyond their control. The participant waives any claim against Aurora Theatre Company and DTT for any such loss, damage, injury, or death. By registering for the trip, the participant certifies that he/she does not have any mental, physical, or other condition or disability that would create a hazard for him/herself or other participants. Aurora Theatre Company and DTT shall not be liable for any air carrier's cancellation penalty incurred by the purchase of a non-refundable ticket to or from the departure city.
